What Does Hospice Offer?

Our goal is to keep patients comfortable and provide support at home so they can enjoy quality time with their families during their final months. Our services include:

- Medical and nursing care with a focus on pain and symptom control.
- Access to a member of our hospice team 24 hours a day, 7 days a week.
- Medical supplies and equipment as needed.
- Counseling and social support to help patients and their families with psychological, emotional, and spiritual needs.
- Nutritional counseling.
- A hospice aide for personal care.
- Respite care for caregivers, family, and others caring for the patient.
- Volunteer support, such as preparing meals and running errands.
- Bereavement counseling and support for loved ones for thirteen months following the death of the loved one.



After the Death: What Do We Do Now?

Throughout a family's time in hospice care, we are blessed to be able to build caring relationships of support and comfort. Often after the death of a loved one, we are asked, "What do we do now?"



Supportive Care Services



To help relieve some of the stress and pressure of obtaining documents and making arrangements, below is a list to help you navigate throughout this process.

- ✓ Locate existing funeral and burial prepaid plans
- ✓ Make funeral, burial, and or cremation arrangements if not already completed



- ✓ Contact Veterans Administration to see if there are any burial benefits (if applicable)
- ✓ Secure the property; lock up the deceased's home and vehicle while going through the legal process
- \checkmark Forward all mail
- ✓ Notify the deceased's employer, ask about paychecks and benefits that may be due. Inquire about life insurance policy through employer
- ✓ When available, secure certified copies of death certificates. Be sure to get

extra copies to close out bank accounts and other open accounts

- ✓ Locate the will or documents that may be in the deceased's living environment to help learn more about all estates and honors
- ✓ Meet with a trust and estates attorney to help understand how to deal with assets
- ✓ Contact probate city and or county to inquire about debts and liabilities to ensure they have been paid
- ✓ Make a list of all assets such as personal property, bank accounts, house, car, furniture, jewelry, etc. Contact an attorney to obtain information on the laws on assets and what's needed for each asset
- ✓ Make a list of bills and share with the executor to ensure expenses are taken care of
- \checkmark Cancel services no longer needed
- ✓ Notify Social Security Administration, life insurance companies, banks. and other financial institutions and credit agencies of your loved one's death
- ✓ Cancel driver's license
- ✓ Close credit card accounts
- ✓ Terminate insurance policies
- ✓ Delete social accounts if applicable
